

# Do you or someone you care for receive Medicaid services under Adoption Assistance or Permanency Care Assistance programs?

Beginning Sept. 1, your care will be provided through a managed care program called STAR or STAR Kids. People in STAR or STAR Kids get basic medical services through a health plan they choose.

STAR is the managed care program for most Texans on Medicaid. STAR Kids is the managed care program for children and adults 20 and younger who have disabilities.

Most Adoption Assistance and Permanency Care Assistance clients will go into STAR on Sept. 1, 2017. Clients who get Supplemental Security Income (SSI) and clients who have a disability as determined by the Social Security Administration or the State of Texas will go into STAR Kids on Sept. 1, 2017.

Because this might change how you find a doctor and services, we want you to learn about STAR or STAR Kids and the health-care choices you need to make.
